



Extended Hours Policy & Registration Procedures

Extended hours services are available to all of our summer camp families. Extended hours run from 7:00 am until 8:45 am and again in the afternoon from 4:15 pm until 6:00 pm. At drop off / pick-up time, parents must sign in / out in the extended day log with appropriate times. There are 2 payment options for extended day:

Extended Day Payment Options

#1 - Pre-Pay Option

With the pre-pay option you register your campers for extended day and pay the appropriate fees with your regular camp payment(s). This entitles you to use all of the hours within the block you register for. **If you sign up for the 8 AM Drop-off or 5 PM Pick-up blocks and use additional extended day hours beyond that you will be billed \$5 per additional half hour used.**

Please fill out the upper portion of the next page to register for Pre-Paid Extended Day.

AM Options

7 AM Drop-off (7:00 – 7:59) = \$60 / child per week

8 AM Drop-off (8:00 – 8:45) = \$35 / child per week

PM Options

6 PM Pick-up (5:01 – 6:00) = \$60 / child per week

5 PM Pick-up (4:15 – 5:00) = \$35 / child per week

#2 - Pay As You Go Option

With this option you will be billed the following Monday for the extended hours you used during the previous week. All invoices will be e-mailed or mailed to you and payment is due upon receipt. Any family who becomes delinquent in paying these invoices will need to pay in advance for all future use of extended day or will not be able to utilize extended day services until the bill is settled. The following is the cost schedule for this option.

***All campers must be picked up by 6:00 PM.

Late pick-ups will be charged a \$1 per minute penalty***

Sibling discounts do not apply towards extended day fees.

Extended Day payments must be made by cash or check only

(Outstanding balances as of September 14, 2018 will incur a 10% late fee)

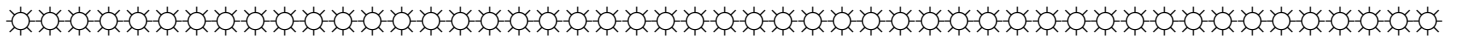
